

THE NABISCO MILITARY BIG GAME SWEEPSTAKES
OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER, WIN OR CLAIM A PRIZE. A PURCHASE OR PAYMENT WILL NOT INCREASE AN ENTRANT'S CHANCES OF WINNING.

The Nabisco Military Big Game Sweepstakes ("Sweepstakes") is sponsored by Mondelēz Global LLC ("Sponsor"), 100 Deforest Avenue, East Hanover, NJ 07936 and is administered by Prize Logic, LLC, ("Administrator"), 25200 Telegraph Road, Suite 405, Southfield, MI 48033.

1. **SWEEPSTAKES PERIOD:** The Sweepstakes begins on January 4, 2022 at 12:00 AM Eastern Time ("ET") and ends on February 13, 2022 at 11:59:59 PM ET ("Sweepstakes Period"). The Administrator's computer is the Sweepstakes official clock.
2. **ELIGIBILITY:** This Sweepstakes is open only to legal residents of the fifty (50) United States (including the District of Columbia) or such residents stationed overseas with an address in the fifty (50) United States (including the District of Columbia) who are active duty U.S. military personnel, veterans, or family of active duty United States military members/veterans and are authorized Commissary and/or Exchange patrons and at least eighteen (18) years old at the time of entry. Employees of Sponsor, Administrator, Defense Commissary Agency (DeCA), Army & Air Force Exchange, HMT Associates, Inc., Coca-Cola Company, Coca-Cola Bottlers, and each of their respective parent companies, subsidiaries, affiliates, advertising and promotion agencies (collectively, "Sweepstakes Entities") and each of their immediate family members (defined as including spouse, biological, adoptive and step-parents, grandparents, siblings, children and grandchildren, and each of their respective spouses, regardless of where they reside) or persons living in the same household (whether related or not) of any of the above are not eligible to enter or win. All federal, state, and local laws apply. Void where prohibited by law.

Participation constitutes entrant's (or entrant's parent's or legal guardian's if entrant is deemed a minor in the jurisdiction in which s/he resides ("Minor") full and unconditional agreement to these Official Rules and Sponsor's decisions and interpretations, which are final and binding in all matters related to the Sweepstakes. For purposes of the Sweepstakes, an entrant's residential address and e-mail address will be the physical address and e-mail address submitted at the time of entry. Entrants will not be allowed to change their physical address or e-mail address on a submitted entry.

3. **HOW TO ENTER THE SWEEPSTAKES:** During the Sweepstakes Period, there are two (2) ways to enter:
 - A. **Text Message:** Using an SMS-enabled mobile device, an entrant must send a text message to the short code "87654" ("Short Code") stating the keyword "FOOTBALL" ("Keyword"). Once the text message is received, the entrant will be sent a reply text message asking the entrant to submit a valid date of birth. Upon receipt of a valid date of birth, and Keyword, an entrant will automatically receive one (1) entry into the Sweepstakes ("Text Message Entry"). Only Text Message Entries to the Short Code with the valid Keyword, and qualifying date of birth will be accepted as a valid Text Message Entry. See Section 6 ("How to Claim a Prize") regarding how potential winners will be notified. All Text Message Entries must be received by Sponsor or its authorized designee by 11:59:59 PM ET on February 13, 2022. NOTE: Proof of text message submission does not constitute proof of delivery or receipt of the text message.

IMPORTANT: Message and data rates may apply for each text message sent or received. Not all mobile telephone providers carry the service necessary to participate in this Sweepstakes.

Entrants should consult their wireless provider's pricing plans. By texting the Keyword to the Short Code, you provide to the Sponsor and Administrator your (or your parent's or legal guardian's if you are a Minor) express written consent for you to receive at least six (6) text messages using automated technology in response to your entry related to the Sweepstakes. Winners will receive at least one (1) additional text message. Consent to receive text messages is not required as a condition of any purchase. An entrant may, at any time, choose to stop participating in this Sweepstakes by sending an opt-out text message stating "STOP FOOTBALL" to the Short Code. If an entrant sends an opt-out text message, he/she will be sent a reply text message, which will confirm that he/she has been unsubscribed and will receive no further text messages. For help, text the word "HELP FOOTBALL" to the Short Code. Each Text Message Entry must be manually key-stroked/entered by the entrant.

- B. Online Entry:** During the Sweepstakes Period, an eligible entrant may visit www.NabiscoBigGame.com ("Website") and complete and submit the registration form with all required information including, but not limited to: his/her first and complete last name (no initials), valid e-mail address, phone number, street address (no P.O. Boxes will be allowed), city, state, and ZIP code. Upon the successful submission of the registration information, an entrant will receive one (1) entry into the Sweepstakes ("Online Entry").

Entry Limit: Regardless of the method of entry, there is a limit of one (1) entry per person per day during the entire Sweepstakes Period. If more than one (1) entry is received from the same person, telephone number and/or e-mail address in a single day, only the first entry received may be considered valid. A "day" is defined as starting at 12:00 AM (midnight) ET and ending at 11:59:59 PM ET on a calendar day during the Sweepstakes Period. Repeated attempts by any person to enter more than one (1) time per day may result in disqualification from the Sweepstakes, at the discretion of the Sponsor.

- 4. RANDOM DRAWING:** On or about February 14, 2022, the Administrator will randomly select one (1) potential grand prize winner and eight (8) potential first prize winners from all eligible entries received through both entry methods combined. Each winner is considered a potential winner pending verification of his/her eligibility and compliance with these Official Rules.

5. PRIZES, APPROXIMATE RETAIL VALUE ("ARV"), AND ODDS OF WINNING:

A. Grand Prize (1): The grand prize is a \$250 Commissary Gift Card and a \$250 Exchange Gift Card ("Grand Prize"). No more than one (1) Grand Prize will be available in the Sweepstakes. The ARV of the Grand Prize is \$500.

B. First Prizes (8): Each first prize is a \$50 Commissary Gift Card and a \$50 Exchange Gift Card (each a "First Prize"). No more than eight (8) First Prizes will be available in the Sweepstakes. The ARV of each First Prize is \$100.

C. Total ARV: The total ARV of all prizes is \$1,300.

D. Odds of Winning: The odds of winning a prize depend on the number of eligible Sweepstakes entries received through both entry methods combined during the Sweepstakes Period.

E. General Conditions: There is a limit of one (1) prize per person. Terms and conditions of Gift Cards apply. In no event will more than one (1) Grand Prize and eight (8) First Prizes, be awarded. If, for any reason, more prize notifications are sent (or more claims are received) than the number of prizes offered, as set forth in these Official Rules, Sponsor reserves the right to award the

intended number of prizes through a random drawing from among all recipients of such notifications combined with all eligible prize claims received.

- 6. HOW TO CLAIM A PRIZE:** The potential winners are subject to verification of eligibility and compliance with these Official Rules. After the random drawing, Administrator will notify the potential winners via telephone or e-mail at the telephone number or e-mail address provided at the time of entry. Each potential winner (and his/her parent or legal guardian if potential winner is a Minor) may be required to complete and return an Affidavit of Eligibility and Liability/Publicity Release (where permitted) within a stated time period as a condition of receiving a prize. Failure to provide all required information and a signature on the documents within the stated time period may result in disqualification and forfeiture of a potential winner's right to claim his/her prize, and may result in the prize being awarded to an alternate winner, if time permits. If a potential winner is disqualified, found to be ineligible or not in compliance with these Official Rules, or declines to accept a prize, the respective prize may be forfeited. All other costs and expenses not expressly set forth herein shall be solely each winner's responsibility. The prizes will only be awarded to verified winners.

Sponsor will attempt to notify each potential winner as set forth above, but Sponsor is not responsible for any undelivered e-mails, including without limitation e-mails that are not received because of a winner's privacy or spam filter settings which may divert any Sweepstakes e-mail, including any winner notification e-mail, to a spam or junk folder. Prizes that are unclaimed, unredeemed, or returned as undeliverable will not be awarded. Prizes are non-transferable and no Prize substitution, exchange or cash equivalent will be allowed, except by Sponsor, who reserves the right to substitute a Prize of equal or greater value in case of unavailability of a Prize for any reason, including but not limited to a force majeure event, at Sponsor's sole and absolute discretion. In no event will more Prizes be awarded than are stated in these Official Rules. In the event that, due to technical, typographical, mechanical, administrative, printing, production, computer or other errors, there are more winners than are stated in these Official Rules, a random drawing among the claimants will be held to determine the winner. Notice of such cancellation, termination, or modification of the Sweepstakes shall be posted at <http://NabiscoBigGame.com>.

IF THE CONTROVERSY OR CLAIM IS NOT OTHERWISE RESOLVED THROUGH DIRECT DISCUSSIONS OR MEDIATION, IT SHALL THEN BE RESOLVED BY FINAL AND BINDING ARBITRATION ADMINISTERED BY JAMS IN ACCORDANCE WITH ITS ARBITRATION RULES AND PROCEDURES OR SUBSEQUENT VERSIONS THEREOF ("JAMS RULES"). THE JAMS RULES FOR SELECTION OF AN ARBITRATOR SHALL BE FOLLOWED, EXCEPT THAT THE ARBITRATOR SHALL BE EXPERIENCED AND LICENSED TO PRACTICE LAW IN MICHIGAN. ALL PROCEEDINGS BROUGHT PURSUANT TO THIS PARAGRAPH WILL BE CONDUCTED IN OAKLAND COUNTY, MICHIGAN. THE REMEDY FOR ANY CLAIM SHALL BE LIMITED TO ACTUAL DAMAGES, AND IN NO EVENT SHALL ANY PARTY BE ENTITLED TO RECOVER PUNITIVE, EXEMPLARY, CONSEQUENTIAL OR INCIDENTAL DAMAGES OR HAVE DAMAGES**

MULTIPLIED OR OTHERWISE INCREASED, INCLUDING ATTORNEYS' FEES OR OTHER SUCH RELATED COSTS OF BRINGING A CLAIM, OR TO RESCIND THIS AGREEMENT OR SEEK INJUNCTIVE OR ANY OTHER EQUITABLE RELIEF.
